VERIFICATION OF SOUTH CAROLINA LEGAL RESIDENCY

It is the policy of the state of South Carolina and the South Carolina Governor's School for Science & Mathematics Accelerate program to consider for enrollment only students whose parent(s) or legal guardian(s) have established legal residency in South Carolina by January 1 of the school year in which the student applies for admission. Your above status for legal residency must remain valid for the entire time you are enrolled in the GSSM Accelerate program.

Legal residency is established when one's principal domicile is maintained in the state of South Carolina. One is considered a legal resident by establishing physical presence in a location determined as his/her home for a period of **indefinite** duration.

A parent or legal guardian of a GSSM Accelerate student must be a legal resident of the state of South Carolina on the date the student begins Accelerate coursework their sophomore year. The parent or guardian must notify the School immediately of any changes in residency.

In order to enroll in Accelerate, you must provide proof of South Carolina residency.

In addition to this signed form, you must submit one item from Group 1 AND one item from Group 2 below.

GROUP 1 - Provide a copy of one of the following

- Parent/guardian's current monthly utility/power bill showing correct name and address
- Parent/guardian's current monthly landline phone bill with correct name and address
- Parent/quardian's current monthly cable bill showing correct name and address

GROUP 2 - Provide a copy of one of the following

- · Parent/guardian's U.S. birth certificate
- Parent/guardian's South Carolina driver's license
- · Parent/guardian's birth certificate from U.S. territory
- Parent/guardian's current U.S. passport

- Parent/guardian's U.S. passport that has not been expired for more than 10 years
- Parent/guardian's certificate of naturalization
- Front and back of the parent/guardian's permanent resident card
